**Abstract.** The paper looks at the present state of the foreign trade of Ukraine which plays an important role in its economy. It analyzes the dynamics of external accounts for the past ten years. The study determines the share of products in Ukrainian export and the portion of products in the total import. It highlights the main trade partners of Ukraine and establishes their share in the foreign trade turnover of goods and services.

The list of its types, namely, export and import of goods, capital and labor is given in Article 4 of the Law of Ukraine «About foreign economic activity». Therefore, the priority task for Ukraine is to achieve an important strategic aim, namely, transfer from export of raw materials to export of finished goods that will considerably contribute to the state budget.

Ukraine as a main form of International business, analysis of external accounts and geographical structure of Ukraine's export and import.
